## Call to Action: Cease Insuring Oil and Gas Projects in Uganda

Today, a coalition of Ugandan youth, climate activists, and environmental advocates, is issuing a compelling call to action directed towards the Insurance Consortium for Oil and Gas Uganda (ICOGU) and its members, including Uganda Reinsurance Company (UgandaRe).

In a collective effort to safeguard the future of our nation and protect vulnerable communities, particularly youth, women, and marginalized groups, we are urging ICOGU to immediately cease insuring projects associated with the oil and gas industry in Uganda. This includes ventures such as the East African Crude Oil Pipeline (EACOP), Tilenga, and Kingfisher.

The decision to issue this call to action stems from a deep concern regarding the detrimental impacts of fossil fuel projects on our environment, economy, and society. The burning of fossil fuels is a primary contributor to climate change, posing grave risks to our planet and exacerbating social inequalities.
